The 2nd European Ecotourism Conference took place in Poiana Braşov, Romania, 23-25 October 2013, supported by the ECOLNET project

The 2nd European Ecotourism Conference held in Poiana Braşov, Romania, from 23 to 25 October, was also scheduled to be the end-of-project Conference of the ECOLNET project. Organised by our Romanian partner, the Association of Ecotourism in Romania, the conference was a great success, bringing together more than 80 professionals of Ecotourism from 22 countries! They learned about the European Ecotourism Labelling Standard -EETLS and the European Ecotourism Network - EEN, exchanged knowledge and experience, discussed best practice in ecotourism and debated the future of ecotourism in Europe.

The four workshops organised in the context of the conference offered a unique opportunity to the participants for information exchange and debate. The topics included:

Improving the benefits provided by Certification programmes and standards. One of the main issues raised concerned the EETLS and its application at national and European levels and its complementary function in relation to existing ecotourism certificates and labels. Various options have been considered so that the implementation of EETLS can be cost-effective and give the maximum benefit to the ecotourism sector. The discussion also explored how

quality certification schemes may contribute effectively to business development and marketing.

Multi-stakeholder approaches to developing Ecotourism destinations.

Specific practices and tools were discussed in connection to these approaches: tools to create, maintain and strengthen the connection between protected areas, local administration and tourism within an ecotourism destination; and practices to encourage joint marketing and management of different ecotourism destinations.

Practical tools for conservation and local development.

The possibilities to maximise the benefit brought in by ecotourism to protected areas and local communities were explored. Participants mentioned practical methods to support nature conservation and local development through ecotourism, avoiding conflicts but providing benefits for both of them.

Product development strategies for better visitor experience.

It was agreed by all that the quality of the visitors' experience depends on good interpretation and appropriate information offered to them. It also depends on the quality of some main 'ingredients' of an ecotourism destination (well-preserved nature and culture, active community,

opportunities for involvement, etc.) that should be monitored and promoted on the European tourism market. All these aspects were discussed and illustrated with examples.

DECLARATION OF THE 2 ND EUROPEAN ECOTOURISM CONFERENCE

A strong point of the Conference was the adoption of the Declaration of The 2nd European Ecotourism Conference through which the professionals of the ecotourism sector expressed their needs and their common principles for a sustainable development of ecotourism destinations.

"Following the deliberations and discussions of the participants of the 2nd European Ecotourism Conference

We recognize these common needs:

- To bring sustainability and nature conservation to the ecotourism destination regions;
- To develop a common understanding of ecotourism in Europe as a conservation and development tool;
- To co-ordinate communications for ecotourism destinations in order to attract quests;
- To communicate the benefits of ecotourism to policy and decision makers.

We agree with the following ecotourism destination concept

Ecotourism destinations in Europe should have:

- A protected area associated with the destination;
- A critical mass of local ecotourism businesses;
- A sustainability plan under implementation, in developing ecotourism;
- Nature and local culture as the main ingredients in product development and marketing;
- Active participation of local communities based on shared values, empowered through education and awareness raising.

We, the 80 participants from 22 European countries, including ecotourism and sustainable tourism associations and networks, ecotourism businesses, education institutions, experts and consultants on ecotourism, have endorsed this statement and committed ourselves to use it as a guide for future action

ECOLNET National workshop in Finland

This workshop, held in Helsinki on the 18th Nov. 2013, rounded up a series of 9 workshops that took place during the ECOLNET project. 23 participants coming from sustainable tourism organisations, education institutes, ecotourism businesses and certification agencies, as well as NGOs, discussed the recent and likely future developments in the field of labelling standards and certification schemes addressing sustainable tourism and ecotourism, with special reference to the EETLS. They also debated on the way these schemes could impact knowledge networks and educational curricula, tools and materials.

Among the speakers, Mr. Pekka Alhojärvi, chairing the event and representing the

European Ecotourism Network, Ms. Katja Winogradow, Dr. Lasse Loven, chairman of the EUROPARC Sustainable Tourism Working Group, Mr. Matti Tapaninen from Metsähallitus (Finnish Forest and Park Service) and Dr. Tuija Sievänen from the Finnish Forest Research Institute (Metla) held active discussions with the participants on ecotourism practices in protected and recreational areas in Finland.



Interesting proposals were put forward and decisions were made, including:

♣ The creation of the EEN Finland to

- ♣ A conceptualisation of this EEN Finland and the definition of its role for the
- A discussion about the future to be held by a working group managed by Pekka Alhojärvi
- A joint task force to be set up consisting of members of research and education institutes, NGOs, SMEs and Metsähallitus, to try and answer the need for further criteria and indicators specific to the Finnish ecotourism sector.
- Regarding educational aspects, the EEN, EETLS and ECOLNET will be presented as new development, accompanied by its own tools, at the Annual Meeting of the Education Institutes of Tourism in Finland, Savonlinna 21-22.11.2013
- ♣ All these proposals and issues will be introduced to and discussed in the EEN Finland forum.

- ♣ provide all ecotourism professionals, especially ecotourism businesses and quality certification agencies,— with a simple and efficient methodology for using the EETLS and the evaluation and learning tools developed by ECOLNET;
- help the users understand the structure and content of the EETLS, obtain a working knowledge of the EETLS criteria and indicators, and provide the means for assessing the compliance of business practices with the EETLS.
- ↓ Guide the users of the self-assessment tool and the integrated evaluation tool to proceed with the rating of their organisation on the basis of the criteria and indicators of EETLS, adopting a step-by-step methodology.

Ecotourism Ireland

The mission of Ecotourism Ireland is to develop high quality ecotourism experiences for the tourism market. We strive to provide an advocacy role to help all our policy makers in Ireland to achieve this aim. These policy makers include, but are not limited to, community network groups, local authorities, Irish tour operators and Government agencies.

We aim to deliver high quality services ranging from ecotourism mentoring, training and certification for a wide variety of business needs. The Ecotourism Ireland label has been recognised by GSTC Global Sustainable Tourism Council. Furthermore, we wish to keep Ireland up to date and aware of the best international developments in ecotourism and share our experiences with others in the field.

We receive no core funding for our activities. We charge a sustainable fee for our work. Since we are a non profit organisation, any profit made in our venture will be reinvested to further develop our role and endeavours.

The Burren and Cliffs of Mother Geopark, awarded UNESCO recognised Global Geopark status in 2011, and Loop Head, which was awarded the Irish Times Best Place to Holiday in 2013. The Burren Geopark estimates that in its catchment area with a population of circa 7,000, there are 550 tourism enterprises (see

www.burrenecotourism.com). The engagement of the Burren Geopark with local communities (named "Burren Connect") resulted in the development of the Burren Ecotourism Network, now with a membership of 39 local businesses, funded by Failte Ireland and by Clare Local Development Company.

We currently are working in 5 destinations in Ireland Meath, Galway, Clare, North Cork and North Kerry and Ecotourism networks are emerging with certified members and supported by Local Development Leader Companies.

Scottish Consortium for Rural Research Seminar: How do we achieve nature tourism growth in Scotland?

Recently, at Our Dynamic Earth, Edinburgh, our partner, the Edinburgh Napier University, and other eight speakers (Forestry Commission, Scotland, RSPB, SNH, Scottish Enterprise, Scottish Tourism Alliance, Seabird Centre, Southern Uplands Partnership, Visit Scotland) presented their views on how to achieve growth in nature tourism in Scotland to an audience of around 40 representatives from the business, NGO, government and academic sectors.

Some of the potential mechanisms suggested included inspiring the next generation to participate in outdoor activities, the need for improved broad band services throughout Scotland, better protection of nature to ensure a high-quality experience for tourists and excellent habitats for wildlife, ensure the accuracy and comparability of data gathered by improving research methodology, develop human capital so local communities can benefit from additional tourism, consider more partnerships and ensure quality of products and experiences (e.g. standards and accreditation such as EETLS, GTBS, VisitScotland).

In addition opportunities and challenges were identified linked to education, infrastructure, the need for innovation and change, investment, marketing, collaboration, leadership, customer management, facilitation, research, etc. A prioritisation process will be carried out on the results with all participants invited to assist in this procedure. The results will then be used to develop strategic action plans and disseminated to individuals involved in all aspects of this sector.

the future and built up their enthusiasm for quality ecotourism.

Some of the piloting businesses received really good ratings on the EETLS criteria, thus demonstrating that EETLS is really a feasible and attainable standard.
