

The ECOLNET project is a 3-year European project, running from 2010 to 2013, co-funded by the E.C. through the Lifelong Learning Programme. It is implemented in 10 EU countries and involves 11 organisations.

The European Ecotourism Network (EEN) is a network of organisations that aims to ensure that ecotourism offerings in Europe are part of a genuine conservation and sustainability effort. EEN supports the development and implementation of the European Ecotourism Labeling Standard (EETLS), a product of a previous Leonardo da Vinci project, ECO-DESTINET, refined and updated by ECOLNET.

## Towards an Ecotourism brand for the Mediterranean: the MEET project

"MEET - Mediterranean Experience of Eco-Tourism" is a 3-year long project funded by ENPI-CBC Mediterranean Basin 2007-2013 Programme, that has granted a budget of about 5 Million € to nine Institutions from six Mediterranean countries.

The project partnership is led by Federparchi - Europarc Italy (the Federation of Italian Protected Areas) and it involves some of the main environment conservation-related policy makers in the region: Lazio Region for Italy, Association of National Parks for France, Cataluña Region for Spain, Egyptian Environmental Affairs Agency for Egypt, Royal Society for



Conservation of Nature for Jordan and Al Shouf Cedar National Park for Lebanon. MedPAN (the network of Marine Protected Areas of the Mediterranean) and the "Med office" of IUCN are also members of the project partnership.

The project aims to develop an integrated strategy to settle an Eco-Tourism planning model for the Natural Parks in the Mediterranean region, model that boosts a better seasonal distribution of tourism flows and establishes a stable cooperation among the Protected Areas, in order to contribute to the design of the Mediterranean basin as a unique destination for ecotourism.

The project starts from the long lasting experience of the "European Charter for Sustainable Tourism" (ECST), already developed in EU-located Parks by Europarc (European Federation of Protected Areas) but intends to make a step ahead in this respect, adapting this approach to the Mediterranean features, and contributing to better design (and differentiate) the Ecotourism among the other nature-based tourism products (Sustainable Tourism, Responsible Tourism, Community-based Tourism, etc.).

The activities started with the design of an Ecotourism participatory-based planning process concept to be implemented in the Mediterranean countries. The project partnership is now defining the criteria for the Pilot Actions: during 2014 at least two Parks for each of the 10 involved countries (Cyprus, Egypt, France, Greece, Italy, Jordan, Lebanon, Malta, Spain, and Tunisia) will start up an Ecotourism planning process which shall have as final output an Ecotourism package. Such packages - from the 20 Protected Areas - will be tested with the relevant tourism targets and will be finally assessed by the project partnership, in order to be part of the "MEET ecotourism offer". A Secretariat (managed by IUCN-Med) will define the trading conditions with previously identified Tour Operators of selected markets like USA, Canada, Australia and Japan.

At the same time in each involved Park a tourism-related SMEs cluster on Ecotourism, involving local economic operators, will be settled, in order to enable the local actors to develop new ecotourism businesses. The last challenge of the project is to set up a "Mediterranean Ecotourism Planning Scheme", i.e. a formal cross-border agreement for cooperating in Ecotourism development, signed by the main Natural Parks-related policy making Institutions of the participating countries, involved in the "Advisory Panel on Ecotourism".

We believe that, since the project MEET analyzes tourism activities in protected areas with a scientific approach based on local experience, it will update the actual know-how of managing and promoting eco-tourism and will bring a significant contribution to the new policies mentioned in many public acts for sustainable development in Mediterranean. Ecotourism in protected areas can become a flagship for policies of economic and social sustainability, as well as renew the alliance between Man and Nature.

The 5<sup>th</sup> Workshop of the ECOLNET Project, entitled "The Future of Ecotourism in Greece: the Contribution of a Labeling Standard" was realized in Athens, on Wednesday 22<sup>nd</sup> May 2013.

The Workshop was attended by key stakeholders in the fields of agrotourism and ecotourism, from all the various types of key areas, who discussed both the problems regarding the development of Ecotourism in Greece, as well as potential solutions.

The Workshop was attended by several of the piloting businesses participating in the ECOLNET Project, members of the Greek Tourism Council, representatives from the Ministry of Agricultural Development and the Ministry of Environment, members of the Hellenic Union of Agrotourism, NGOs' active in the field of Environmental



For a period of two days, the participants will be involved in debates and fruitful discussions regarding the current understanding and future development of new ecotourism initiatives in Europe.

The piloting phase of the ECOLNET Project started in November 2012, aiming to test the friendliness and effectiveness of the online evaluation tools and Learning Packages with associations and businesses in the ecotourism field, including quality certification agencies.

The piloting is in its final stages: the results are being gathered, conclusions made, and revisions on the way!
